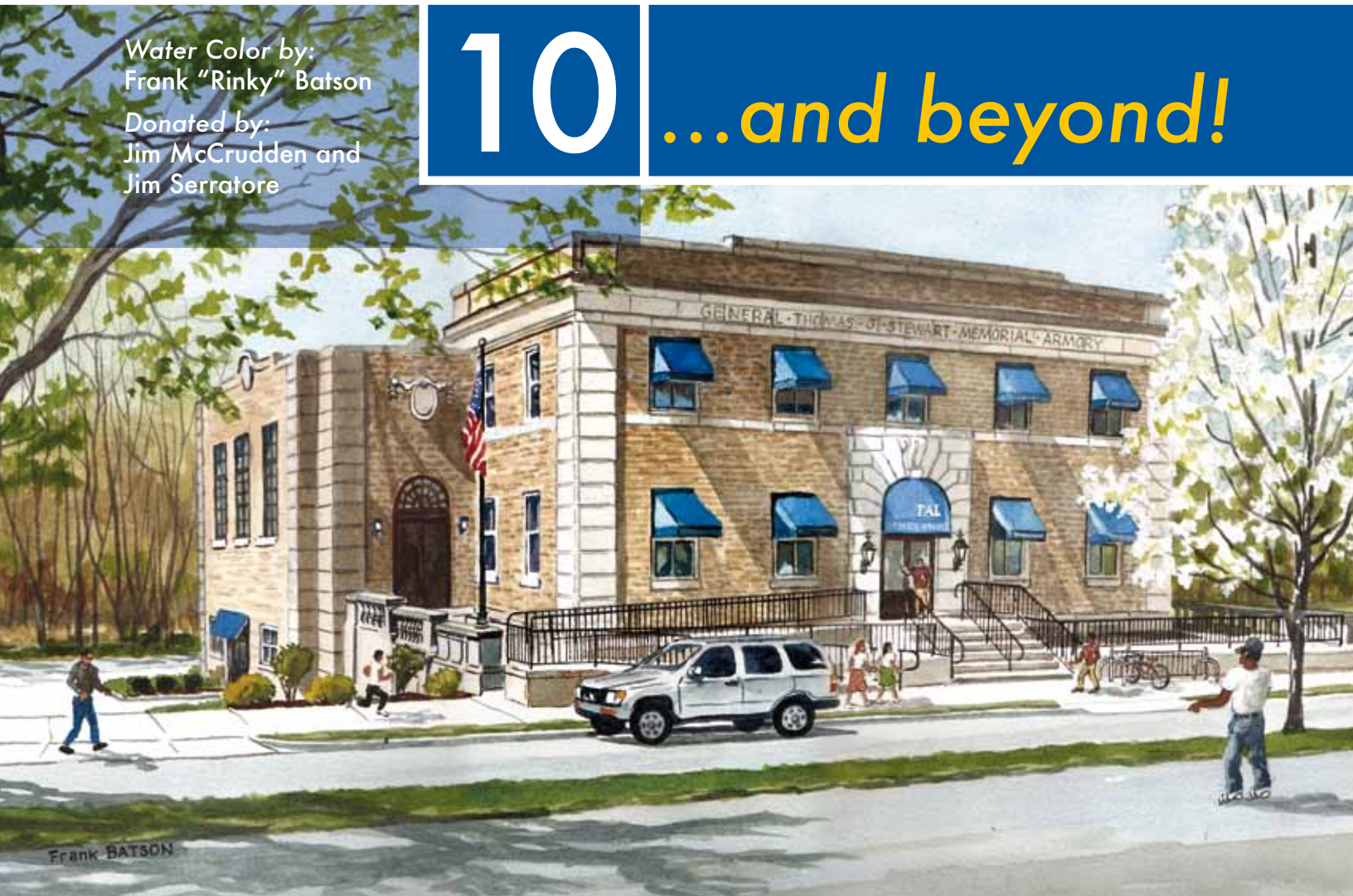

Board President 2007-2009

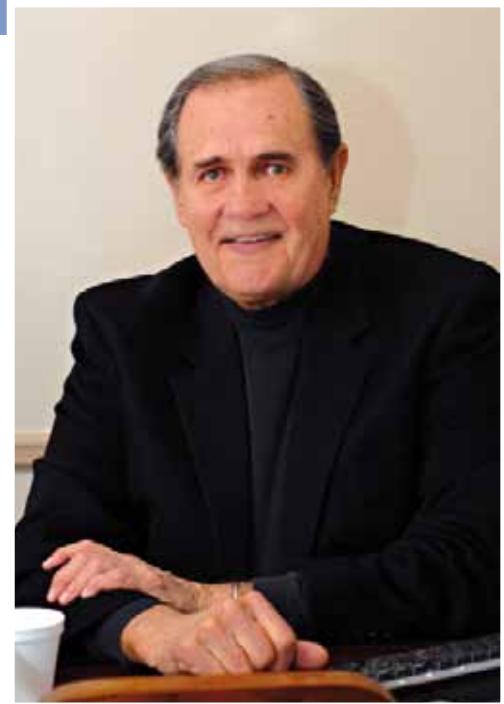
When Jim assumed the position of Board President in early 2007, Greater Norristown PAL was in the midst of major transition. He immediately recognized that the organization faced several challenges:

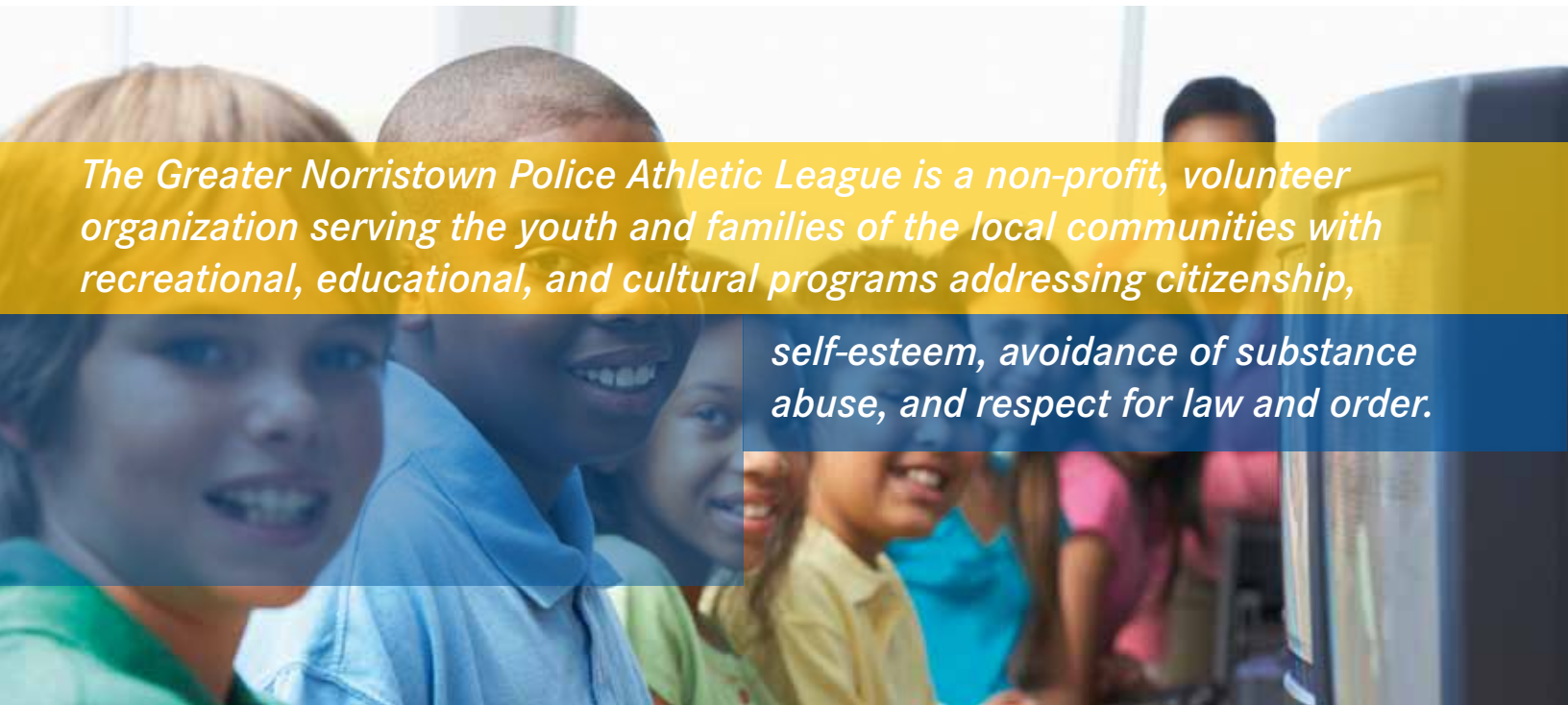

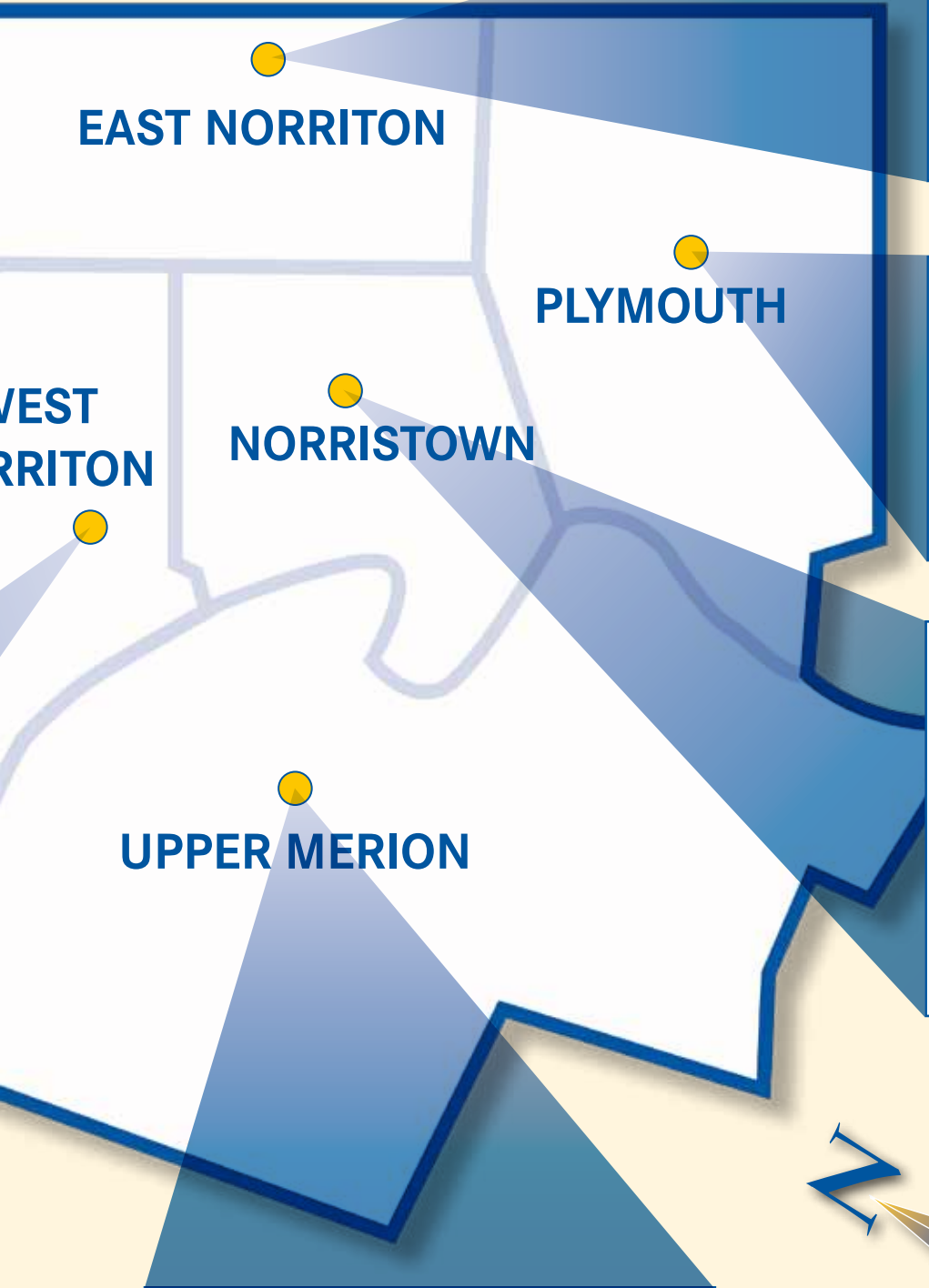

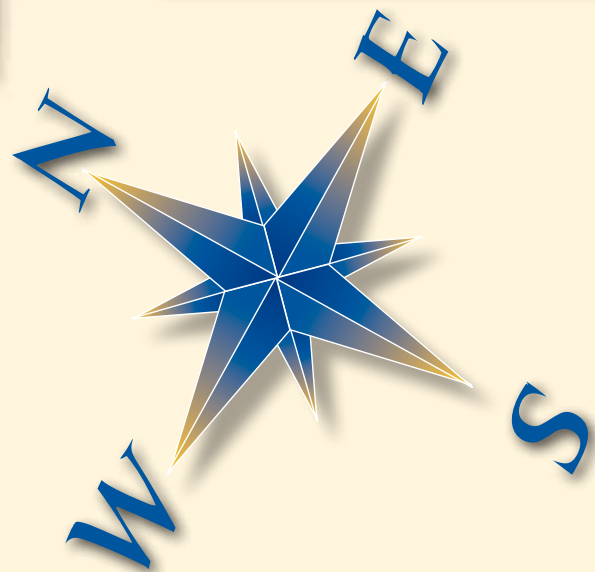

Historical Overview of GREATER NORRISTOWN PAL

In 1974 several Norristown Police Officers decided to start a chapter of the Police Athletic League in Norristown to provide activities for Norristown youths. They enlisted businessman Sal Gambone and attorney Frank O'Hara to help with the required paperwork. The charter was granted in 1976, and the first PAL programs consisted of basketball tournaments of area public and parochial school teams and sponsoring a Norristown Little League team. Their programs expanded to include computer classes, all of which were held in schools and churches.

Following a long period of inactivity, Sal Gambone, Frank O'Hara and others resurrected Norristown PAL in the mid 1990's, with activities again based in schools and churches. When Pennsylvania decided to sell the Stewart Armory, the board submitted a bid. Although unsuccessful in their first attempt,



the building was purchased in 2001. Refurbishing it presented a formidable challenge, both financially and physically.

Finally in the summer of 2004, the PAL Center opened its doors.

Thanks to the vision and efforts of community leaders, such as Sal Gambone, Harry Mirabile, George Fairel, Willie Richet, John Parker, Russell Bono and others, GNPAL continues to grow. Total youth membership numbers over 1,000 who participate in a diverse offering of athletic, cultural and educational activities. An additional 4,000 people use the facility yearly for educational, therapeutic, and life skills programs.





EXTENDED PROGRAMS

A wide variety of athletic and educational programs is crucial for Greater Norristown PAL to fulfill its mission.

GNPAL offers a comprehensive selection of recreational and athletic programs. Basketball continues to be played year round, while youths may also compete in boxing, track and field, lacrosse, wrestling, tennis, and soccer, as well as Tae Kwon Do and biking. Members may also participate in open gym time. Additionally, GNPAL has hosted both local and regional Junior Olympics Skills Competitions.



Educational and artistic opportunities complement the sports programs. Educational opportunities have included Hands-on

Science night, Earth Day activities, Family Night programs, Tutoring and Truancy Abatement program, FAME (Fun Activities for Middle school Enrichment) summer programs, Chess Club, Etiquette for Girls, Summer Job Interview training for high school students, Science on Patrol classes at two middle schools through the School Resource Officers who are also providing extended GNPAL programs in their schools.

The Elegant Steppers Dance Unit, Mexican Folk Dancing, Hip Hop Dance/ Capoeira, Line Dancing, Latin Jazz Percussion lessons and performance through Music Copia, and guitar lessons are examples of GNPAL arts and cultural programs.





EDUCATIONAL PROGRAMS

Learning that **BROADENS** the **MIND**

Greater Norristown PAL sponsors six Family Night programs during the school year. These programs are designed for elementary-aged students and provide activities the whole family is able to enjoy. In many cases these programs serve as an exciting introduction to GNPAL.

Summer programs include non-athletic activities for middle school-aged students at a nominal fee. Examples range from horseback riding, film photography, community art, and fishing, to field trips to the Times Herald, the DEP “green” building, the Historical Society, the Cultural Center, as well as Montgomery County Community College, Arnolds, and the Franklin Institute.



The GNPAL computer lab seats 18 students, in a classroom configuration,



and the library is stocked with books for students of all ages. MCCC has held courses in the Computer Lab and in the Center’s three classrooms. After school tutoring is also offered free of charge during the school year.

Cultural activities, like music and dance classes, are held based on the availability of instructors. A chess club has recently been formed. Plus, an anti-drug and alcohol student group was formed in collaboration with Communities That Care.



COMMUNITY SERVICE

Actions that **BROADEN**
the **SOUL**

Greater Norristown PAL effectiveness is in part due to its community and collaborative efforts with other nonprofits.

The GNPAL Center is used by the police department for training and for SWAT's annual workout. Glen Mills School staff meets at the Center with former students as they transition back into the community. Youths perform court mandated community service. It is also the central collection site for the Law Enforcement Food Drive.

Communities that Care and GNPAL sponsor Back Talk, a student group focusing on keeping youths safe and drug free. Cabrini College's involvement at GNPAL includes student volunteers, service



projects, and youth classes on self-esteem and how students identify with sports figures.

Activities held at the Center include:

- The Montgomery County Black Law Enforcement Officers Association meetings.
- The Philadelphia United Cerebral Palsy's wheelchair hockey team practices and games.
- The Service Employees International Union's English as a Second Language Classes.
- Carson Valley Children's Aid's Parenting Classes.
- The American Red Cross' blood drives.
- Halloween Helpers' distribution of gently used Halloween costumes to area youths.
- Conicelli Auto Dealerships kids new winter coats distribution.
- Girl Scout troops meetings.
- GNPAL and area nonprofit agencies' Youth Rally.
- Martin Luther King Day, United Way Day of Caring, and Earth Day community service site.

GNPAL participates in the Annual Youth Summit at Eisenhower Middle School and was actively involved with the Norristown Fourth of July Parade.

ATHLETIC PROGRAMS & TEAM ACCOMPLISHMENTS





Greater Norristown PAL athletic programs have gained recognition on larger stages. In its fifth year, the K-9 wrestling program draws participants from five communities, as well as the Norristown area.

In 2008, six wrestlers qualified for the State Tournament with one state champion. In the 2009 Inter County Wrestling League (ICWL) Tournament, the wrestlers finished with three firsts, a second, a third and a fourth. Four wrestlers qualified for the State Tournament with three going on to Eastern Nationals and finishing seventh, fifth, and second. Eleven wrestlers competed on state and national squads.

Last year's Norristown Area High School (NAHS) League Championship team had six K-9 alumni on its squad, one of whom qualified for states. Chestnut Hill Academy's varsity squad had one K-9 alumnus while LaSalle College High School had two. Two of these wrestlers placed in their postseason tournaments. This year eight Norristown PAL Wrestling alumni start for their high school team.

GNPAL took great pride in the 2008 NAHS basketball team's season which ended as runner up in the PIAA State Basketball tournament. All the team members started their careers playing PAL youth basketball and members of that team now play collegiate basketball.

In only their second season, last year's GNPAL Track Team had 20 participants qualify for the AAU National Championships. Two team members were recognized by the Middle Atlantic States Division of the US Amateur Track Association for their performances. One participant drove from Scranton-Wilkes Barre area to compete with the GNPAL Track Team.

The Eisenhower Tennis Association was honored by the USTA Mid-Atlantic Division's Community Tennis Association for bringing tennis to area youths through their partnership with GNPAL. Now the GNPAL Boxing program is ready to start competition and could be the next sport to bring GNPAL recognition.

The Harry P. Mirabile, Sr. Scholarship

The Harry P. Mirabile, Sr. Scholarship is awarded yearly to area students to further their post secondary education. The GNPAL Board of Directors has approved the awarding of a maximum of three \$1,000 scholarships each year.

Applicants must currently be a high school senior or an undergraduate at a post secondary school with a grade point average equivalent to a 2.0 on a 4.0 scale. Volunteering at GNPAL and community service are also prerequisites for consideration.



The 2009 GNPAL Mirabile Scholarships were awarded to Taja Hinton, Corrine Fuentes, and Olivia Corner, all 2009 graduates of Norristown Area High School. Olivia is enrolled at Bloomsburg University and has not decided on her major, while Corrine is studying architecture at Philadelphia University. Taja also stayed in the Philadelphia area and is an English major in the College of Liberal Arts at Temple University.
